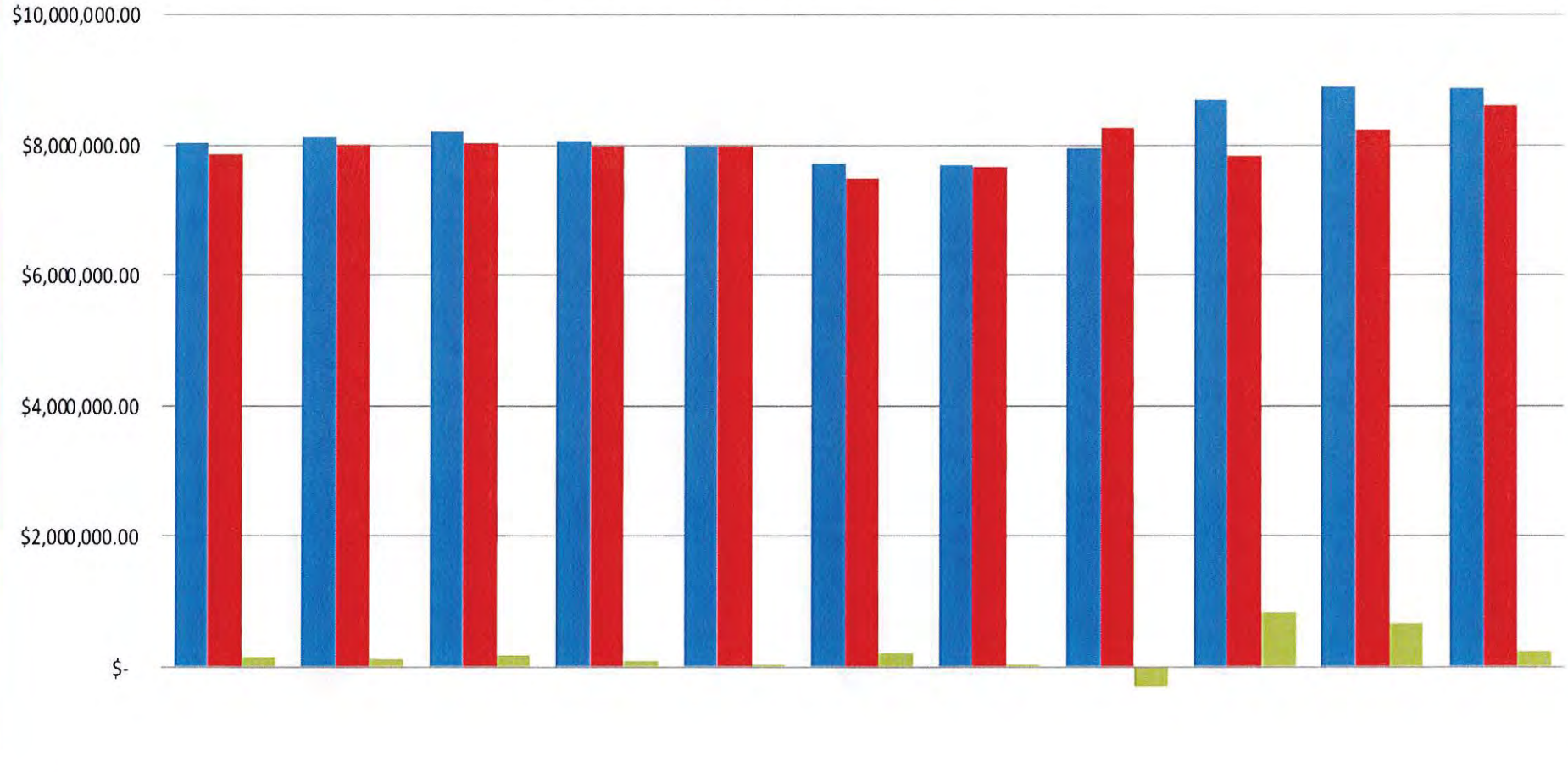

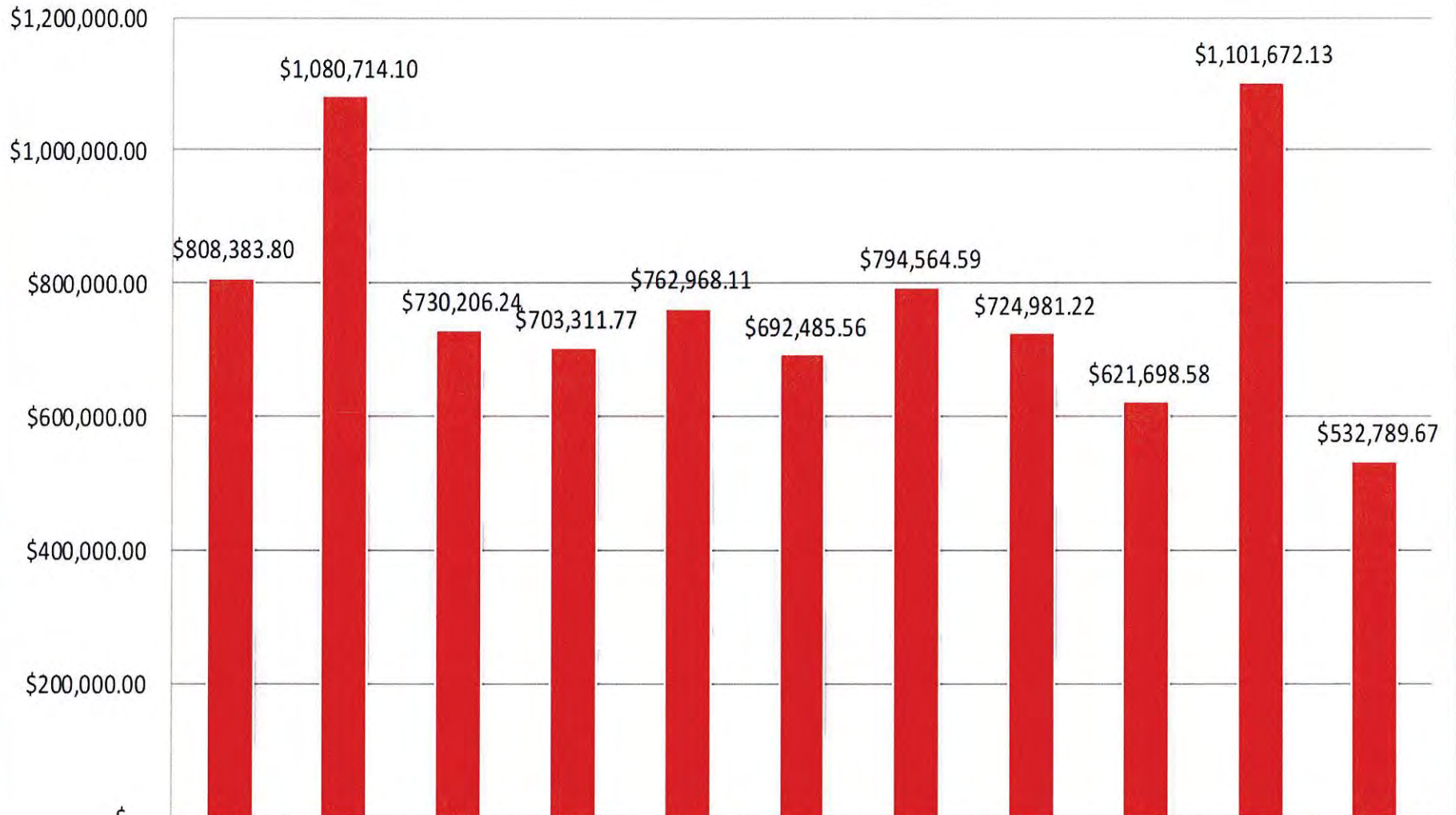
General Fund Totals as of June

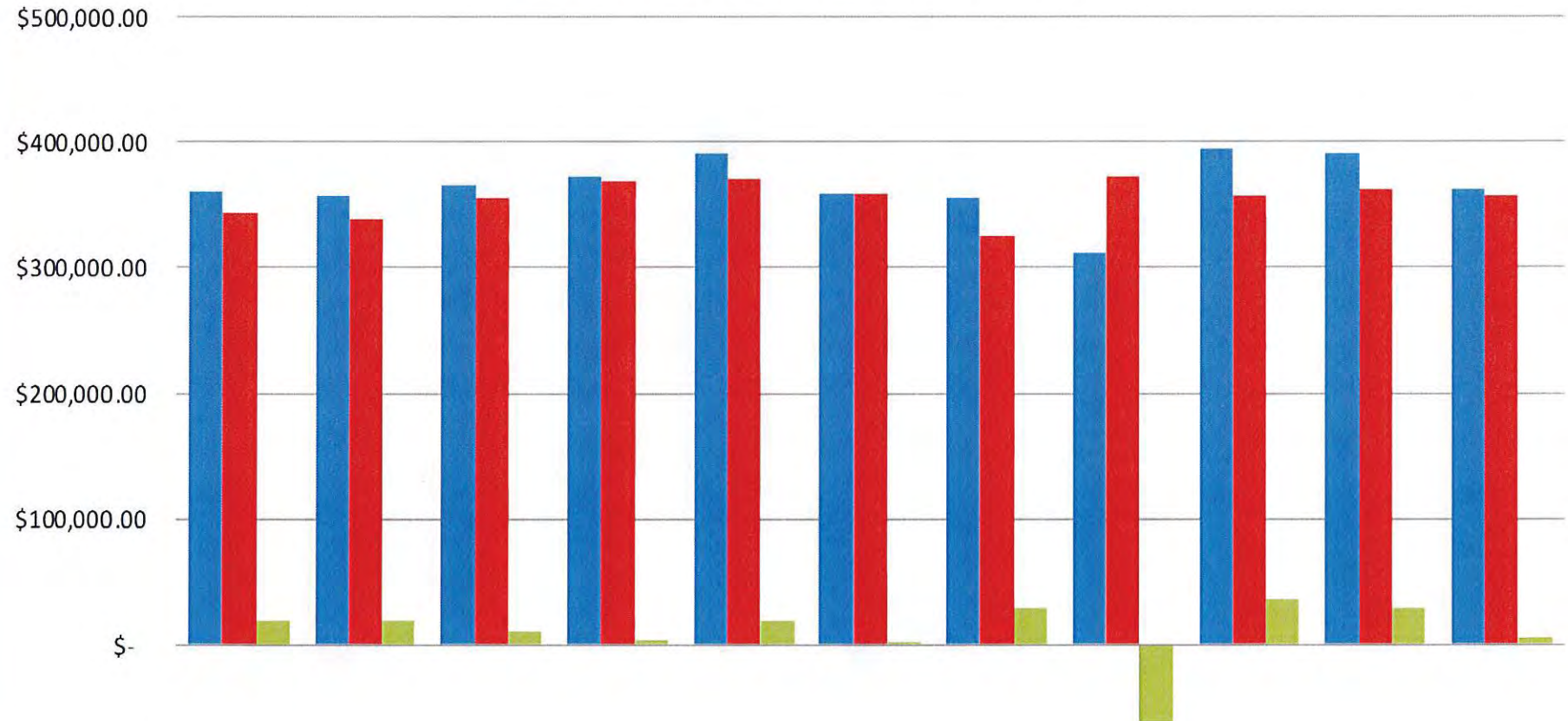
