ADMINISTRATION OF MEDICATION TO STUDENTS DURING SCHOOL HOURS

All medication should be given at home when possible. The administration of prescribed medication and/or medically-prescribed treatments to a student during school hours will be permitted only when failure to do so would jeopardize the health of the student, the student would not be able to attend school if the medication or treatment were not made available during school hours, or if the child is disabled and requires medication to benefit from his/her educational program. In the event that it is necessary for a student to receive medication during the school day, the following requirements must be met prior to the administration of medication:

- **PRESCRIBED MEDICATION:** A Prescribed Medication Form must be completed and signed by both the physician and parent/guardian.
- **OVER THE COUNTER MEDICATION (Nonprescription):** An Authorization for Over the Counter Medication form must be completed and signed by the parent/guardian.
- It is the student's responsibility (age appropriate) to report to the clinic at the designated time to receive the medication ordered.
- All medication **MUST** be brought to school by the parent/guardian. Students are not permitted to carry or transport medication unless previously authorized by the school, physician, and parent/guardian and is an Emergency Medication (EpiPen, Inhaler, etc.).
- All Prescription Medication must be labeled appropriately by the pharmacist or physician and in its original container. The label must state the student's name, dosage, and time(s) to be taken and must match the Prescribed Medication Form.
- All Nonprescription medication must also be in its original container and labeled with a permanent marker indicating the child's name. Medication not in its original container will NOT be accepted or administered to the student.
- The recommended dosage on the box of the nonprescription medication will be reviewed and compared to the parent/guardian request. If the dosage exceeds amount recommended on the medicine box/container, it must be requested by a physician's order on a Prescribed Medication Form.
- The principal or trained personnel will supervise the administration of the medication in the absence of the nurse.
- Any change to the medication must be submitted on a new Prescribed Medication Form. If a prescription medication is to be discontinued, a written note must be provided by the prescribing physician. Verbal request from parent accepted with written request from physician required the following day. Faxes will be accepted as well.
- New medication forms (either Prescribed Medication or Over the Counter Medication) must be submitted for each new school year and for each medication.

Parent(s)/Guardian(s) MUST pick up any unused medication. Medication will not be sent home with the child unless previously authorized and is an Emergency Medication. All medications not retrieved will be disposed of according to Ohio Revised Code.
