### GENERAL REQUIREMENTS FOR SCHOLARSHIPS

- A. The scholarships are awarded to students, who are <u>residents</u> of Trumbull County, Ohio and <u>cannot afford</u> to pursue post-secondary educational opportunities, including college degree programs or other certificate programs (i.e. trade or technical schools) without financial assistance.
- B. Recipient selection preference is given as follows:
  - -First preference to students without parents, guardians or other means of non-state support;
  - -Second preference to students of need in foster home care;
  - -Final preference to students of need in difficult life circumstances.
- C. Scholarships are granted without regard to sex, race, or creed and are granted in amounts up to \$3,000.00 with a general renewable period of three additional years.
- D. Scholarships are paid directly to the educational institution selected by the student to be used first for tuition and fees and then books with remaining monies used for room, board, etc.
- E. Completed application and specific scholarship requirements listed below must be returned to your school counselor or other administrator, who must submit applications to the Bentley Trust by Friday, April 11, 2025. Incomplete Applications will not be considered.
- F. In addition to the Application, you must submit:
  - 1. Transcript showing grade average, class rank and college test scores.
  - 2. Two (2) letters of reference from teachers, counselors, or school administrators.
  - 4. Completed and executed financial need form (included in packet).
  - 5. A letter of confirmation from the educational institution that you are accepted for enrollment.
  - 6. One page statement of a. your career goals, b. special interests and achievements, c. work and extracurricular experience, and d. expected tuition, need and other scholarships received.
